STEPS TO BE TAKEN IF MATERIAL IS RELEASED OR SPILLED: Read all product instructions before using. Personal protective equipment should include impervious gloves, protective eye wear, and suitable work clothes. Uncured product is very sticky, so carefully remove the bulk of the foam by scraping it up and then immediately remove residue with a rag and solvent such as polyurethane cleaner, mineral spirits, acetone (nail polish remover), paint thinner, etc. Once the product has cured, it can only be removed physically by scraping, buffing, etc. Dispose as plastic waste (foam plastic) in accordance with all applicable guidelines and regulations.

7. Handling and Storage

HANDLING: Make sure nozzle is directed away from yourself prior to discharge. Keep away from open flames, hot surfaces and sources of ignition. Use only with adequate ventilation. Ensure fresh air entry during application and drying. Do not breathe dust. While dry sanding, use of a NIOSH-approved dust mask is recommended. Contains isocyanates.
